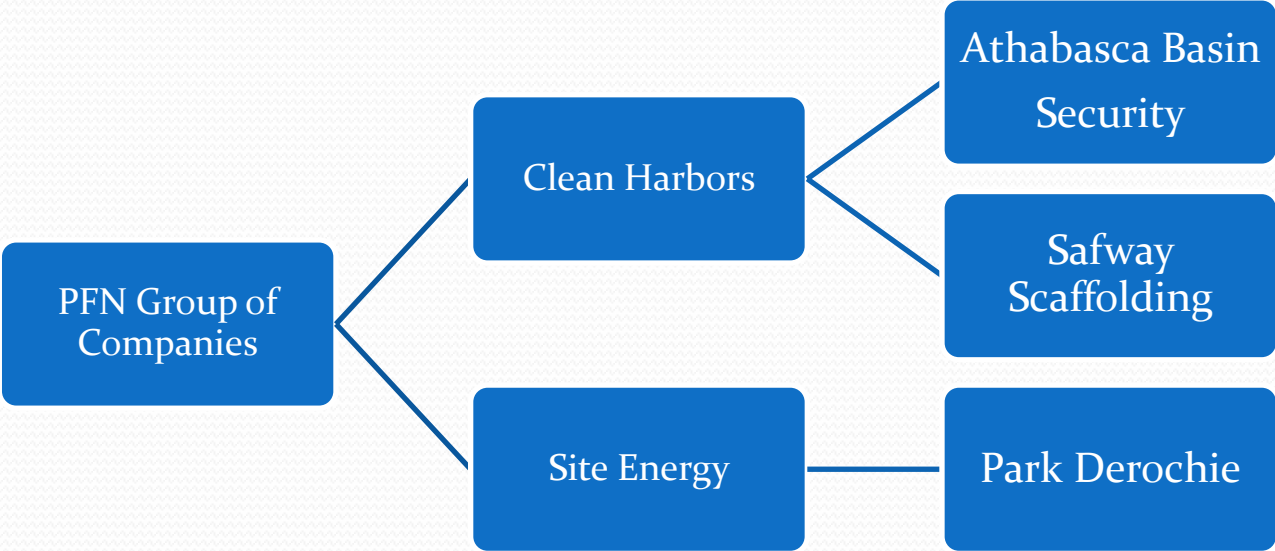
# Mission Statement
