TREATY LAND ENTITLEMENT



TLE BACKGROUND

- Pasqua First Nation TLE Settlement approved by ratification vote in **2008**.
- Total shortfall acres required: **6,686.55**
- Acres Purchased to date total **8,989.21**
- Lease Revenue from lands purchased are payable to Pasqua TLE Holdings Inc.
- Lease revenue pays land taxes and/or land improvements.
- Bank Balance ending December 31st each year is payable to RBC Revenue Account.
- Annual Lease Revenue: **\$230,000.00** approximately
